Consistent with its acquisition philosophy, Cavotec MSL expects to further develop the Dabico business by supporting the current management team and employees, with Bill Fischer as President (US) and Gary Matthews as Managing Director (UK). Going forward, Dabico will operate under the name of Cavotec Dabico.
